re: Abolishing of the Sinai Torture Camps

During the winter of 2010, reports began being published on the torture camps in the Sinai where Ethiopian, Eritrean, Sudanese, and other immigrants and refugees, are kidnapped by the Bedouin tribe "Rashida". This tribe kidnaps helpless and defenseless human beings for the sole purpose of collecting a ransom for their release. During their kidnapping they suffer abuse, which includes beating, electrocution, severing of body parts and possibly harvesting of body organs. During these horrendous events in the last two years, approximately 4000 human beings have been slaughtered. Amongst the kidnapped, hundreds of women and girls have been raped and have undergone inhumane sexual torture; young children and babies have been seriously injured or simply murdered. Hundreds of these kidnapped people have reached Israel and have reported and given evidence to their horrendous ordeals.

According to the reports from the last few months, the massive illegal border infiltration into Israel has been halted mainly due to the border fence that has been erected. Still the victims of these torture camps continue reaching the Israeli-Egyptian border, injured and exhausted. It transpires from the testimonies of these victims that most of them had no initial intention of immigrating to Israel, but were kidnapped from their refugee camps in Sudan and Ethiopia. After being tortured and abused, they were released along the border of Egypt and Israel. The leaders and operatives of these torture camps are criminals and deserve to be treated to the full extent allowed by law. This small group of people is extremely dangerous and is harming both Egypt and Israel.

We reach out to you in the strongest possible way to stop this horrendously cruel and inhumane injustice. We fear that the torture camps and harvesting of body organs, which provide for very large sums of money to these cruel people, may cause this sickening phenomenon to grow as a cancer if they shall not be brought to justice soon.

Egypt and Israel cannot stand by while such inhuman acts are being performed right before their eyes. Protecting the victims of human trafficking is a both a Muslim and Jewish duty. We urge you to cooperate as soon as possible to stop this horrible phenomenon, as written: "The voice of thy brothers' blood crieth, does not say brother's blood but brothers' blood, his blood and his seeds blood" (Senhadrin 4 E)
